Click "Sign up for FREE"



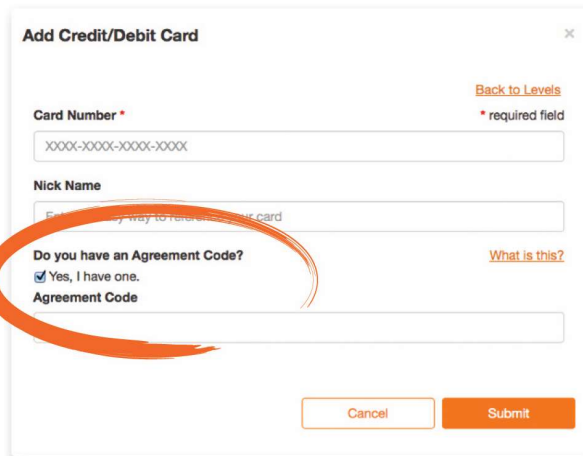
**2. CREATE ACCOUNT**

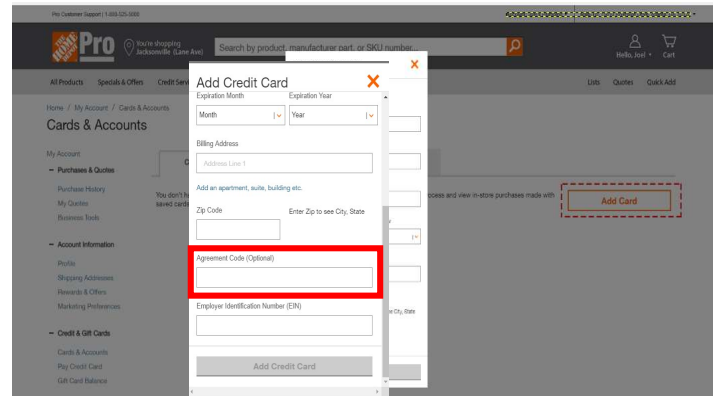
1. Select 'Cards & Accounts' from the dropdown menu at the top of the screen
